



1. The cost of bid documents (non-refundable) mentioned in column No. 5 should be deposited in shape of demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna.
2. The cost of EMD in column No. 3 should be deposited in shape of demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna.
3. Quoted rates should be quoted clearly in both figures & words with corrections duly attested by the quotationers.
4. The quotationers should submit detailed & satisfactory establishment information capable for preparation & supervision of such project.
5. The firm/ institution should have GST Registration Certificate, PAN . No undertaking would be allowed against non-submission of any required document.
6. The Quotation will be opened at 11.00 AM on dt. 15.10.2025 in presence of the bidders or their authorized representatives, who may be present at the time of opening of the bids.
7. The intending bidder should submit individual sealed cover/ envelope superscribing the title "("Tender for Outdoor LED Display System", quotation Call notice number & date).
8. The quotationer shall submit the photo copy of PAN and GST with their quotation.
9. The quotationer shall submit the photo copy of Registration certificate of MSME from any Govt. Registration Dept. with their quotation.
10. The quotation shall submit the photo copy of assignment or order they have got supply & installation of the similar work from any Govt./Private sector as a proof of experience with their quotation.
11. The bidder should have not been debarred/ blacklisted by any Central / State government department / public sector undertaking / other government entities or local body in last 05 years in India prior to the date of issue of this quotation. (Undertaking to be submitted on non-judicial stamp paper).
12. The quotationer shall ensure the period of warranty at a time line of at least 01 years from the date of completion of installation (Undertaking to be submitted on non-judicial stamp paper).
13. The quotationer shall ensure the complete maintenance against the commodity supplied by them.
14. At least 3 years of experience in supplying and installing outdoor LED systems.

15. Authorisation from LED panel manufacturers or OEMs.
16. Financial turnover of at least Rs. 40.00 Lakhs in the last three financial years.
17. Equipment must be delivered within 15 days from the date of purchase order. Installation and commissioning should be completed within 20 days from delivery.
18. A delay of more than 30 days in delivery or installation will attract a penalty of 0.5% of the total contract value per week, subject to a maximum of 5%.
19. All technical and operational data shared between the municipality and the vendor must be treated as confidential.
20. Any disputes arising from the contract shall be governed by the laws of India and settled in the jurisdiction of Bhawanipatna.
21. Maintenance services during the warranty period must include troubleshooting, repairs, and part replacement at no additional cost. Post-warranty AMC (Annual Maintenance Contract) options must be provided.
22. The municipality reserves the right to terminate the contract in case of non-compliance, poor performance, or breach of terms with prior notice.
