



  - \* Quotations must be typed or neatly written and duly signed with seal by the authorized representative of the firm.
  - \* The bidder must attach self-attested copies of GST Registration Certificate, PAN Card, Authorization Certificate (if any), and past supply experience (if available).
  - \* The cost of bid documents (non-refundable) Rs.600.00 (Six Hundred) only should be deposited in shape of demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna.
2. The cost of EMD of Rs. 2000.00 (Two thousand) Only in shape of demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna.

## 3. Quality Requirements

- Tyres supplied must be new, unused, and from the latest manufacturing batch.
- Only reputed and standard brands will be accepted.
- The tyres must carry manufacturer's warranty for the specified period.

## 4. Delivery Terms

- All items must be delivered to the Municipality Store Section, Bhawanipatna.
- The supplier shall complete delivery within 7 (seven) working days from the date of the Supply Order.
- Materials will be inspected by the authorized officer before acceptance.

## 5. Payment Terms

- Payment will be made after complete supply, inspection, and verification of materials.
- No advance payment will be made.
- Bills must be submitted in duplicate along with warranty details.

## 6. Validity of Quotation

The quotation shall remain valid for 30 (thirty) days from the last date of submission.
